The 37th Regiment Virginia Infantry was accepted into the service of the Confederate States July 1, 1861, and reorganized April 22, 1862. Companies G and I were consolidated under Captain Bussey after the October 31, 1862, muster, but each company appears to have been mustered separately. Most of the members of the regiment were captured in May, 1864, and the remnants of all the companies were later assigned to Companies H and K.
